**NOTES:**

1. Games will be played at **Memorial Church of Christ** – Address: 900 Echo Lane 77024 (across from Memorial High School), **Rummel Creek Elementary School**, 625 Brittmore, 77079 (turn north off Memorial Drive between West Belt and Wilcrest), and **Memorial Drive Elementary**, 11202 Smithdale.
2. Coaches should contact League Commissioner and opposing coach if unable to play as scheduled. Games will not be re-scheduled.
3. Game times are in 90-minute time slots. The first 40 minutes of each time slot is the official practice time for the two teams. The remaining time is devoted to game play until the 90-minute slot is consumed. Each game will consist of 4 quarters of 6 minutes each (or longer to consume the entire 90 minutes).
4. Each player from both teams will shoot one free throw at the end of each half with the points contributing toward the team’s total for the game. (Each team will shoot the same number of free throws. If one team has fewer players, then players on that team who miss their first shot will shoot the additional free throws.)
5. Won/loss records will not be maintained.
